THE THIRD SPECIAL SESSION ENDS AND ELECTION SEASON BEGINS

As mentioned in previous newsletters, this summer and fall were filled with back-to-back special sessions. On, October 19, 2021, the third and final special session of 2021 adjourned with rumors of a fourth special session to follow. To date, a fourth special session has not been called. There were ten items on the Governor's proclamation for the legislature to debate during the third called session. The most critical item was redistricting—the drawing of new maps for the US House of Representatives, Texas Senate, Texas House of Representatives and the State Board of Education based on the most recent Census data. All maps were signed by Governor Abbott and effective, but are now in litigation. The upcoming primary and general elections will be based on these maps.

Additionally, bills relating to interscholastic athletic competitions, higher education benefits for survivors of public servants, property tax exemptions, unlawful restraint of dogs, supplemental appropriations, and tuition revenue bonds passed during this special session. The items that did not pass are vaccine mandates, bail reform, and additional election fraud bills. Some of these issues were continued from previous special sessions.

Usually, the fall following the legislative session includes the release of interim charges for the committees to study prior to the next legislative session. As you may expect, the interim charges have not been released, but are expected in early 2022. Interim charges give insight and allow for any preparation and research on potential issues for the upcoming session to be completed. We will pass along any information of interim charges impacting land and mineral owners.

Since the passage of the new legislative maps this fall, the March 2022 primary election candidate filing dates have come and gone. Five Senators and 25 state representatives, including long-time committee chairmen and chairwomen, announced they would not seek reelection of their current seats. Some are seeking other offices and some are retiring from public service. These numbers do not account for any incumbents that are defeated in their primary or general elections. This means that the 2023 legislature will again see significant turnover in both chambers.

All statewide offices are on the 2022 ballot—including one Railroad Commissioner seat and a vacant Land Commissioner office. Wayne Christian is the Railroad Commission incumbent and he is seeking reelection. Land Commissioner George P. Bush is running for Attorney General. As a reminder, TLMA does not have a PAC or take a position in races. However, we can provide you biographies of the candidates at the appropriate time.





DO YOU NEED TO GET A COPY OF A DIVISION ORDER? HERE'S HOW!

Division Orders are arguably one of the most pertinent legal records for mineral royalty owners. In most cases, a single well will have multiple owners. Therefore, it is imperative to have an accurate and updated division of interest for producing wells.

A Division Order will include the owner's decimal interest (net revenue interest (NRI)), type of interest (ex: royalty, mineral or working interest), the producing property's name (legal description and/or well name and number) and the owner's name.

The Division Order is sent from the operating company to the owners of an interest in the producing well. They are *created* once the title has been confirmed, a well has been drilled and production has begun. However, a Division Order is generally *received* by a mineral royalty owner through the mail, often months after well completion. Therefore, you should not be expecting a Division Order on a well that is not yet complete.

Once a mineral owner receives a Division Order, they must review it, sign it, and send it back to the operating company. It is vital that the mineral royalty owner review it closely and ensure all information is accurate. Do not sign and return the Division Order unless you are confident it is accurate, and you are satisfied with all information outlined. If information is not accurate, you must contact the company who issued the Division Order. We recommend making a copy of all Division Orders you receive for your records and have a good digital document management system. It is also important to know that in most cases owners will not receive royalty payment until they have signed and returned a Division Order.

If you know you should have received a Division Order but have not, there are a few things you can do to help expedite and rectify the issue.

- Contact your Operator (this information can often be found online)
- Contact the Purchaser of the oil and natural gas
- Contact a Mineral Management company or other professional

When you contact the Operator, ask to speak to a division order analyst. Division Order Analysts are responsible for maintaining the company's pay decks and ensuring that the ownership information is correctly maintained in the operator's system. Most operators have an email on their website for owner relations, start by sending an email to this email address and including your name, address, and owner number. Provide them any recorded documentation that you have from the appropriate county clerk where the properties are located. If you recently inherited the mineral rights, then provide them with the former owner's name, address, and social security number along with any estate documents (probated will, letters testamentary, affidavit of heirship). Making sure that you provide the correct and full data to the operators will make the process easier and more efficient for them to transfer the royal-ty interests. If for some reason you are unable to reach the division order analyst after trying to contact them via phone and email, consider composing a letter and include all the information above and mailing it to them certified with the USPS.

If you find yourself not able to keep up with your Division Orders or want to add another set of eyes to reviewing all information, there are companies and professionals who can assist.
